All the interested Agency/ contractors will deposit Rs. 5000/- as Bid Security in the shape of Accounts Payees Bank Draft or duly pledged Fixed Deposit Receipts in order to avoid back out by any party/ Firm. The Bid Security of unsuccessful bidder[s] shall be refunded to them at the earliest after the expiry of final validity period of the bid as stipulated in the tender documents and the bid security of successful bidder shall remain in the custody of department till the completion of contract of outsourcing of services by the contractor to the best of satisfaction of the Department.

Performance Security shall be obtained from the successful bidder on the award of the contract irrespective of his registration status, which shall be for an amount between five to ten percent of the value of the contract. Such security shall be furnished in the form of an Account Payee Demand Draft or duly pledged fixed deposit receipt or Bank Guarntee From a commercial bank, as the case may be, in an acceptable form with a view to safefuard the interest

of department. which shall remain valid for a period of sixty days from the date of completion of contract.

6. This office reserves the right to postpone, extend the date of receipt/opening of Tender/quotations or to withdraw the same, without assigning any reason thereof.
