7. Incomplete offer or offers not confirming fully to the Technical Essential requirement or with vague replies or without Earnest Money will not be considered.

8. The Chairman of the Departmental Purchase Committee of Himachal Pradesh Police reserves the right to Cancel/ Reject any or all the tenders without assigning any reason.

9. The Chairman reserves the right to increase or decrease the quantity as per availability of funds.

12. Tenderers are required to quote rates FOR at consignee's locations only.

13. Stores are required to be dispatched by firm by road transport under their own arrangement to the consignee location within 60 days from date of placing supply order.

14. The store should be packed in such a way that it is not damaged during transportation.

15. Bidders offering import store shall make their own arrangement to deliver the goods at consignee's location and should quote accordingly.

16. Firms/ Tenderers should mention price of each item separately.

17. The full name and status of the person signing the tender documents must be clearly mentioned in their tender documents.

18. **EARNEST MONEY:** - All the firms who are not registered with Store Purchase organization of HP/DGS&D/ NSIC for the subject stores as per specification shall be required to deposit fixed amount of Earnest Money. Offers received without Earnest Money other than the amount specified will be liable to be summarily ignored. Registration with any other organization or to any other specification will not be exempted from depositing Earnest Money.

Public Sector Undertakings / State Govt. undertakings or Central / State owned companies are not exempted from the payment of Earnest Money unless registered with DGS&D / NSIC.

19. SECURITY DEPOSIT:- The successful firm shall have to deposit 10% of the contract value on account of performance security deposit in the shape of Bank Draft or Bank Guarantee or Fixed Deposit Receipts duly pledged in name of the Drawing & Disbursing Officer, PHQ, Shimla-02, Himachal Pradesh within 30 days of from the date of receipt of technically cleared supply order. Failure at the part of the firm to deposit the Security Deposit within stipulated time will make the supply order null and void.

20. The Performance Security Deposit submitted by the supplier will remain valid for a period of 60 days beyond guarantee/warranty period.

21. Liquidated damages: In case the firm does not complete the supply within the delivery period then liquidated damages charges will be imposed @ 0.5% per week i.e. 2% per month subject to 10% maximum on total value of the items.

22. The radio set should have provision of standard slot facility for installation of "encryption device". The OEM of the Radio should give an undertaking that they will give details of Interface for developing encryption in India whenever required by HP Police. The developing agency will give NDA (Non disclosure Agreement) to OEM". Copies of the same shall be enclosed with tender.

23. As per the Compulsory Enlistment Scheme of the Department of Expenditure, Ministry of Finance, Govt. of India, it is compulsory for Indian agents who desire to quote directly on behalf of their foreign manufacturers/ principals, to get themselves enlisted with the Department of Expenditure, through the Central Purchase Organization (e.g. DGS&D).

24. If bidder is not an OEM then bidder should be authorized by OEM for the offered equipments and bidder should provide authorization certificate from OEM.

25. Bidder to give details of the OEM customer service center registered in India with service tax number to ensure prompt after sales service/support for warranty and post warranty services. (OEM certificate to be attached).

26. Supplier should provide after sales support, supply of spares for at least 7 years after warranty period and spare parts availability.

27. Supplier should provide a certificate from the OEM that the measurement of the equipment is made in accordance with EIA/ TIA / ETSI/FCC.

28. The firm should enclose valid DOT/WPC license for supplying radio equipment in India.

29. TERMS OF PAYMENT: 100% payment of the stores will be made on bill basis after receipt of the items in good condition by the consignee after successful inspection/survey/checking and acceptance.

30. In case offers are received both from manufacturer as well as from their agent, offers from manufacturers only shall be considered and offer from their agent shall be summarily rejected.

31. EVALUATION OF THE PROPOSAL: A two stage procedure will normally be adopted.

a) Stage-I: Technical Evaluation-

Technical bids to assess their suitability against the laid down Technical Specifications/QRs./Make/Model will be evaluated. Tenderers must ensure that they enclosed all original technical literature and detailed documentary proofs which specifically bring out the compliance of the equipment being offered against the QRs/Specifications.

All the parameters as per technical specification (**Given in Annexure-B&C**) will be checked by a departmental technical committee. Field trial of the offered equipment will be conducted by a Departmental Technical Committee in the operational area of Himachal Pradesh Police in the presence of the vendor/representative of firms to ascertain the user satisfaction. The vendor should carry Digital Radio Communication Tests sets required for testing of parameters of Digital Radios as per tech. specifications during field trials on site in CTS Workshop, Shimla HP. All the technical features will be shown during the trials.

b) Stage- II: Financial Evaluation-

The price bids of only those stores found acceptable in technical evaluation shall be opened, evaluated and considered further. It is in the tenderers interest to include all relevant and detailed technical data with their bid.

32. Condition of the Contract: - The contract agreement will be made with successful Tenderer as per **annexure-H**.

33. Period for which offers will remain open: - Tendering firms should note the period for which their offers should remain open for acceptance. Offers from those firms who have not kept the validity open till the period stipulated in the tender enquiry, will be treated unresponsive and will be ignored without making any back reference. Tendering firms may further note that in the absence of any indication of the date up to which the offer has been kept valid, it will be assumed that their offer will remain open for acceptance for the period specified in the tender Enquiry.

34. Extension of Validity & Earnest Money :- If the validity of the tender is extended, the validity of the Earnest Money in whatever form submitted will also have to be suitably extended by the Tenderer failing which their tender shall not be considered by the purchaser after the expiry of the aforesaid period.

35. REFUND OF EXCESS PAYMENT: Supplier has to refund the excess payment if any made for Sale Tax, Excise Duty and Custom Duty etc.

36. EARNEST MONEY DEPOSITED & PERFORMANCE SECURITY MONEY WILL BE FORFEITED in case suppliers breach the contract in any sphere.

IMPORTANT INSTRUCTIONS

1. Guarantee / Warranty:

(i) Except as otherwise provided in the invitation to the tender, the contractor hereby declares that the goods/stores/articles sold/supplied to the purchaser under this contract shall be of the best quality and workmanship and new in all respects and shall be strictly in accordance with the specification/Brand and particulars contained/mentioned in the contract. The contractor hereby guarantees that the said stores/goods/articles would continue to conform to the description and quality aforesaid for a period of **02 years and 12 months for accessories and rechargeable batteries** from the date of acceptance of the equipment at purchaser end, if during the **aforesaid period** the said stores/articles/goods be discovered not to conform to the description and quality aforesaid or not giving the satisfactory performance or have deteriorated and the decision of the purchaser in that behalf shall be final and binding on the contractor and the purchaser shall be entitled to call upon the contractor to rectify the goods/stores/articles or such portion thereof as is found to be defective by the purchaser within a reasonable period of such specified period as may be allowed by the purchaser in his discretion on an application made thereof by the contractor and in such a event, the above mentioned warranty period shall apply to the goods/articles/stores rectified from the date of rectification thereof. In case of failure of the contractor to rectify or replace the goods etc. within specified time, the purchaser shall be entitled to recover the cost with all expenses from the contractor for such defective stores.

(ii) Guarantee that they will supply spare parts, if and when required on agreed basis for an agreed price. The agreed basis could be and including but within any limitation on agreed discount on the published catalogue or on agreed percentage of profit on the landed cost.

CONDITIONS OF CONTRACT

The contract agreement is between the Chairman, of the Departmental Purchase committee & _____ from _____ to _____. But in the event of any breach of the agreement of any time on the part of the contractor the contract may be terminated summarily by the Director General of Police, Himachal Pradesh, Shimla without compensation to the contractor.

Any change in the constitution of the firm shall be notified forthwith by the contractor in writing to the authority sanctioning the contract and such change shall not relieve any former member of the firm from any liability under the contract.

1. No new partner/partners shall be accepted into the firm by the contractor in respect of this contract unless he/they agree to abide by all its terms, conditions and deposit with the officer sanctioning the contract a written agreement to this effect. The contractor's receipt of acknowledgement or that of any partners subsequently accepted as above shall bind all of them and will be sufficient discharge for any of the purposes of the contract.

2. The contractor will supply nothing but genuine Digital VHF transceivers sets of technical specifications as per Annexure-B&C, of the rate contract from time to time in such quantities as may be entered in the supply order sent at the rates quoted. No guarantee can be given as to the quantity, which will be ordered during this period. The purchaser reserves the right of placing orders of equipments as given in Annexure-B&C with one or more contractors as he may think fit and the contractor binds himself not to revoke this contract during the said period. The Director General of Police/Chairman Purchase Committee reserves to himself the right to obtain contracted items of stores when available from any Government department/approved source without any prejudice to this contract. He further reserves the right to negotiate any of the tenderers and award parallel rate contract to any or all of the participating tenderers.

3. The equipments to be supplied under this contract will be of the quality equal and answerable in every respect to the specifications given at Annexure-B&C with the tender and approved by the Director General of Police, Himachal Pradesh. The Contractor shall be responsible for all complaints as regard the quality. In case any of disputes regarding quality of articles; the decision of the Director General of Police will be final and binding on the contractor. It will be open to the Director General of Police/Chairman Purchase Committee or any consignee to send samples submitted by the tenderer/contractor to any laboratory for lab test report and the cost thereof will be borne by the tenderer/ contractor.

4. The Director General of Police/Chairman Purchase Committee, may by notice in writing call upon the contractor to supply additional articles to serve as sample, and upon receiving such notice in writing the contractor shall at his own cost be bound to supply the additional samples, such additional samples being in all respects of the same quality as the sample first supplied.

- 5.** The contractor will be responsible for damage or loss in transit and replace goods broken or lost within 10 days from the date of notice thereof.
- 6.** All equipments must be dispatched within 60 days of the receipt of supply order by the contractor.
- 7.** Conditions as to time for performance whether laid down therein or in any terms shall be always regarded as the essence of the contract.
- 8.** The Director General of Police, Himachal Pradesh or the Chairman Purchase Committee or any of the experts attached to the Police Department of Himachal Pradesh or consignee or any other Officer or person duly authorized by authority shall have the power to inspect the Stores before, during or after manufacture, collection, dispatch transit or arrival and to reject the same or any part or portion after the written approval of the Director General of Police, Himachal Pradesh. The contractor shall provide without any extra charge all materials, tools including testing appliances, for making necessary tests for the purpose of ascertaining whether the same are in accordance with the technical specifications, labour and assistance of every kind which the aforesaid officer may consider necessary for any test or examination which he may require to be made on the contractor's premises/workshop and shall pay all cost attendants thereon.
- 9.** The bill will be prepared in triplicate and submitted by the contractor to the consignee for direct payment. The full amount will be paid on receipt of stores, in good condition after their verification/inspection/survey as regards specification etc.
- 10.** If, during the currency of the contract the specification of any equipment to be supplied there under be changed the contractor shall continue to comply with demands for the supply of the said equipment in accordance with the new specifications at a rate to be mutually agreed to in writing at the time of such change and in default of such agreement the contract in so far as it relates to the said article or articles under respect of which no agreement has been arrived at shall terminate but no such change shall effect the supply of any other articles under the contract or entitle the contractor to any compensation.
- 11.** In the event of withdrawal or discontinuance of any equipment and consequent ceasing of or reduction in demand the contractor shall not be entitled to any compensation.
- 12.** The time for and date of delivery or dispatch stipulated in the said schedule shall be deemed to be the essence of the contract and should the contractor fail to deliver or dispatch any consignment within the period prescribed for such delivery or dispatch in the said schedule then without prejudice to his rights otherwise the purchaser shall be entitled to recover from the contractor a sum of equal 2% of the contract price of such consignment for each and every month or a part of a month during which the supply of dispatch of such consignment may be in arrears or alternatively at the option of the purchaser. The purchaser, shall be entitled to purchase such consignment (or if not available the best and the nearest available substitute therefore) elsewhere on the account and at the risk of the
