- ii. Bidders are advised to study the tender document carefully and thoroughly. Submission of bid shall be deemed to have been done after careful study and examination of the tender document with full understanding of its implications.
- iii. Bidders should ascertain whether they meet the below mentioned eligibility criteria for bidding.
- iv. Bids with price variation clauses or with vague terms are liable to be ignored and rejected. Incomplete bids are liable to be rejected.
- v. It will be imperative on each bidder to fully acquaint himself with all the local conditions and factors, which would have any effect on the performance of the contract and cost of the goods.
- vi. The bidders must submit their bid online by the bid submission end date for online submission as specified in the Key Dates. 3. LATEST INSTRUCTIONS FOR BIDDERS:-

- I. Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority as defined vide Office Memorandum (F. No. 6/18/2019-PPD) dated 23.07.2020 of Ministry of Finance, Department of Expenditure, Govt. of India.
- II. "Bidder" (including the term 'tenderer', 'consultant' or 'service provider' in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process.
- III. "Bidder from a country which shares a land border with India" for the purpose of this Order means:
 - a. An entity incorporated, established or registered in such a country; or
 - b. A subsidiary of an entity incorporated, established or registered in such a country; or
 - c. An entity substantially controlled through entities incorporated, established or registered in such a country; or
 - d. An entity whose beneficial owner is situated in such a country; or
 - e. An Indian (or other) agent of such an entity; or
 - f. A natural person who is a citizen of such a country; or
 - g. A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.
 - IV. The beneficial owner for the purpose of (III) above will be as under:-

- **B.** In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;
- **C.** In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- V. Where no natural person is identified under (I) or (II) or (III) above, the beneficial owner is the relevant natural person who holds the position of senior managing official:
- VI. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
- VII. An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
- VIII. The successful bidder shall not be allowed to sub-contract works to any contractor from a country which shares a land border with India unless such contractor is registered with the Competent Authority.
- IX. The Bidder has to provide declarations (duly signed and stamped) as per Form-IX to XI of this tender.

Note: Interested bidder may refer to Office Memorandum (F. No. 6/18/2019-PPD) dated 23.07.2020 of Ministry of Finance, Department of Expenditure, Govt. of India for further details and all the requirement will be in accordance with this memorandum.

4. PURCHASE PREFERENCE FOR LOCAL MICRO AND SMALL SCALE UNITS/ STARTUP ENTERPRISES OF THE STATE:-

The following purchase preference ratio shall be applicable to the Local Micro and Small Scale Units of State and Local Micro and Small Scale categories under H.P. State Startup Scheme on the lowest approved rates provided that products offered by these units meet the required quality standards.:-

- 1. Local Micro and Small Scale Units of State of H.P. =15%
- 2. Local Micro and Small Scale categories under H.P. State, Startup Scheme=15% (Total Purchase Preference =30%)

Provided that if Startup Enterprises will not be available, then 30% purchase preference shall automatically be given to Local Micro & Small Scale Unit and vice versa as the case may be.

The Startup Enterprises/ units in micro and small scale categories, in the manufacturing sector may also be exempted from the prior experience/ turnover requirements provided they meet the requisite quality standards as laid down in the tender. It is reiterated that Purchaser's decision regarding Bidder's eligibility will be final and binding on all the Bidders. MSE/Startup registration certificate should be attached.

5. PURCHASE PREFERENCE TO MAKE IN INDIA (MII)

The 'Class-I local supplier' shall get purchase preference over 'Class-II local supplier' as well as 'non-local supplier' as per following procedure:-

- i. Among all qualified bids, the lowest bid will be termed as L1. If L1 is 'Class-I local supplier', the contract for full quantity will be awarded to L1.
- ii. If L1 is not 'Class-I local supplier', 50% of the order quantity shall be awarded to L1. Thereafter, the lowest bidder among the 'Class-I local supplier' will be invited to match the L1 price for the remaining 50% quantity subject to the Class-I local supplier's quoted price falling within the margin of purchase preference and contract for that quality shall be awarded to such 'Class-I local supplier' subject to matching the L1 price. In case such lowest eligible 'Class-I local supplier' fails to match the L1 price or accepts less than the offered quantity, the next higher 'Class-I local supplier' within the margin of purchase preference shall be invited to match the L1 price for remaining quantity and so on, and contract shall be awarded accordingly. In case some quantity is still left uncovered on Class-I local suppliers, then such balance quantity may also be ordered on the L1 bidder.

For this purpose:-

'Local content' means the amount of value added in India which shall, unless otherwise prescribed by the Nodal Ministry, be the total value of the item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.

'Class-I local supplier' means a supplier whose goods offered for procurement meets requirement of the minimum local content of 50%.

'Class-II local supplier' means a supplier or service provider, whose goods, services, or works offered for procurement, meets the requirement of minimum local content of 20% but less than that prescribed for 'Class-I local supplier' as above.

'Non-local supplier' means a supplier or service provider, whose goods, services or works offered for procurement, has local content less than or equal to 20%.

"Margin of purchase preference' means the maximum extent to which the price quoted by a 'Class-I local supplier' may be above the L1 for the purpose of purchase preference. The margin of purchase preference shall be 20%.

The 'Class-I local supplier'/ 'Class-II local supplier' at the time of bidding shall be required to indicate percentage of local content and provide self-certification that the item offered meets the local content requirement for 'Class-I local supplier'/ 'Class-II local supplier', as the case may be. They shall also give details of the location(s) at which the local value addition is made.

Note: Interested bidder may refer to order No. P-45021/2/2017-PP(BE-II) dated 16.09.2020 issued by Govt. of India, Ministry of Commerce and Industry Department for Promotion of Industry and Internal Trade (Public Procurement Section) for further details and all the requirement will be in accordance with this memorandum.

Note: Micro and Small Enterprises will get precedence over purchase preference under Make in India.

6. VALIDITY OF THE TENDER

Offer should be kept open for acceptance for a period of 12 months from the date of opening of bid. A bid valid for a shorter period may be rejected by the purchaser as non-responsive. Any increase in rates within this period will not be entertained and will result in forfeiture of EMD and / or Security Deposit.

7. ELIGIBILITY CRITERION

- I. The bidder should be OEM or their authorized dealers for participating in the tender.
 - (A) In case of OEM, Manufacturing Proof i.e. Performance Materials and Technologies (PMT)/ Entrepreneurs Memorandum-II (EM-II) Certificate/ Conformity of Production (CoP)/Udyog Aadhaar Memorandum (UAM), must be uploaded.
 - (B) In case of Authorized Dealers, following documents must be uploaded:-
- (a) Bidder(s) are required to upload proper authority letter(s)/authorization(s) from their Principal Manufacturing firm(s) in original on their letter pad(s) for quoted item(s) in which the participating firm has been authorized to participate, quote the rates and supply the material on behalf of the Principal Manufacturing firm(s) in Himachal Pradesh alongwith validity period of dealership.

- (b) In the case of authorized dealers participating in the tender will have to submit the latest manufacturing proof of Principal Manufacturer(s) for quoted item(s) i.e. EM-II Certificate (latest manufacturing proof and production certificate) from General Manager, District Industries Centre concerned/valid registration with NSIC for quoted item(s) not more than one year old as on the date of opening of tender.
- II. If the bidder participates in the capacity of Partnership firm, then the bidder must upload the copy of Partnership Deed & Power of Attorney in which the bidder/person/official has been authorized to sign the tender documents on behalf of the firm.
- III. The bidder must upload/submit an attested copy of valid BIS Certificate for requisite equipment/item along with complete details of equipment covered in BIS Licence.

- V. The bidder's and OEM's average annual turnover should not be less than Rs. 10.00 lakh over last three financial years. The bidder must submit copies of balance sheet of last three financial years in respect of bidder and OEM duly signed by a Chartered Accountant. The bidder must fill and enclose the prescribed (**Form VII**).
- VI. At the time of bid, bidder must not be blacklisted from any Govt. Organization / Body in India. Declaration certificate must be submitted as per enclosed prescribed **Form -VIII.**
- VII. The bidder must be a registered dealer under any State's GST Act and Central GST Act and must upload a scanned copy of GST registration certificate alongwith latest GST Clearance Certificate/clearance receipt of last GST returns of the preceding year which should not be more than one year old.
- VIII. The OEM and its Bidder must have ISO Certification. Copy of the same is required to be submitted.
- IX. The bidder must attach declarations regarding restrictions on procurement from a bidder of a country which shares a land border with India as per **Form-IX to Form-XI**.

8. PROCEDURE FOR SUBMISSION OF BIDS

- i. An eligible bidder is to fill up online e-tender on website https://hptenders.gov.in up to prescribed date and time and also the bidder is to submit technical bid in hard copy. The technical bid shall contain tender fee, EMD, all other documents mentioned in the tender document and at sr. no. 10 i.e. technical bid except the price part of the bid.
- ii. **The Financial bid/BOQ** shall contain the details of the price in Indian rupees inclusive of all taxes, duties, charges, F.O.R., in words as well as figures.
- iii. All the bid papers must be signed. The information submitted must be definitive and specific. Vague terms, incomplete information, counter offers, and 'uncalled for' correspondence shall not be entertained.

iv. Bidder is required to submit the complete bid along with annexure & brochures of the quoted equipments etc. The bid document has to be signed and stamped by the bidder. The proposal shall be exactly according to the presented formats given in the TENDER documents.

9. EARNEST MONEY DEPOSIT

A sum of Rs. Fifty thousand only should be deposited as Earnest Money Deposit (EMD) in the shape of FDR / Bank Guarantee issued by any Indian Nationalized Bank having validity period of 6 (six) month duly pledged in favour of the DDO, PHQ, HP, Shimla-2.

- (i) Registered Local Enterprises and Micro & Small Scale Enterprises, which are also registered with the State Store Purchase Organization **for such items**, shall be exempted from the deposit of earnest money.
- (ii) Similarly, Small Scale Industrial units registered with the N.S.I.C. for such items shall also be exempted from the deposit of earnest money. The Himachal Pradesh State Government undertakings and the Government of India Undertakings shall also be exempted from the deposit of earnest money.

(Exemptions:- In such cases the bidders are required to upload a scanned copy of proof of exemption i.e valid registration with Store Purchase Organisation, H.P./ NSIC for quoted items.)

11. FINANCIAL BID/BOQ

- i. Price quoted by the bidder in the BOQ should be uploaded in financial bid folder.
- ii. Rates to be quoted must be definitive and shall not be allowed to be altered.
- iii. Price to be quoted should be inclusive of all taxes, installation charges, duties and F.O.R. in the office of the undersigned. Rates be quoted in terms of unit, in words and figures both.
- iv. Tender will be awarded taking into consideration the rate of the complete camera system including installation charges.

12. PROCEDURE OF FINALIZATION OF BIDS

- i. Firstly, the technical bid shall be opened. At the time of opening of bid, the authorized representative may remain present. Technical bids will be evaluated in consonance with eligibility criteria etc. and technical specifications mentioned in the tender. The bidder should submit brochures/pamphlets/leaflets/literature, if any, of quoted item (s) for technical evaluation with technical bid.
- ii. The information submitted by the bidders shall be compared with specifications given in the tender form. It will thus be ascertained whether the product offered by the bidder matches with the technical specifications of this tender.
- iii. The committee would be entitled to call for any further information, document, undertaking and may also interview the authorized representative of the bidder in order to satisfy itself about the eligibility of the bidder, technical specifications of the equipment, trust worthiness of the product. The decision of the committee on technical suitability of the offer shall be final.
- iv. If required, technically qualified bidders (in document scrutiny stage) may be asked to give field trial/demonstration of the offered equipment before committee of this office at Shimla. The field trial and any damage shall be at the cost of bidder.
- v. **Financial bids/BOQ** of only technically qualified bidders shall be opened. Rest bids shall not be considered and such short-listed bidders will be intimated about the date and time accordingly. At the time of the opening of Financial Bids/BOQ, authorized representatives may remain present. It shall not be obligatory to accept only the lowest financial bid.
- vi. All or any bid may be rejected. The essence is that only such bid that in the opinion of the Purchase Committee or the DGP HP is most suitable for HP Police shall be selected.

13. DELIVERY PERIOD

- 1. Purchase order and installation of whole equipment should be executed with in 60 days from the date of issue of purchase order.
 - 2. The supply and installation may be executed in the office of the undersigned.

14. RIGHT TO VARY QUANTITIES

The Purchase Committee or the DGP HP reserves the right to vary the quantity within the validity of the tender without any change in price or other items and conditions with commensurate increase or decrease in delivery period. The approximate requirements are given in the tender document. But it must be clearly understood that the demand may fluctuate and no definite quantity can be guaranteed. Bidder shall be bound to supply the item(s) in such a quantity as required by H. P. Police.

15. CONSIDERATION - Price, Taxes etc. and Payment Terms

- i. The supplied equipments will be tested/surveyed/inspected in our office and if found as per technical specifications of tender document and to the entire satisfaction of the deptt., payment will be released.
- ii. The prices quoted for the items shall be firm throughout the period of agreement and shall not be subject to any upward modification whatsoever.

16. PENALTY CLAUSE

In case the firm does not complete the supply and installation within in the stipulated time as prescribed in the tender document, then liquidated damage charges will be imposed @ 0.5% per week i.e. 2% per month subject to 10% maximum on total value of the items. Delivery period can be extended with / without L.D. maximum for 60 days on the request of Bidder / Supplier by the competent authority, while considering merits and demerits of the case. Extension of delivery period will be the sole discretion of the Purchase Committee, HP Police, Shimla-2.

17. FORCE MAJEURE CLAUSE

No extension of the scheduled delivery or completion dates shall be granted except in the events of force majeure instances of lockouts, labour disturbances, war, acts of Govt, terrorist activities, military operations, riots, epidemics etc upon which, neither party has any control and have arisen not due to any act or omission imputable to any of the parties, shall be construed to be sufficient ground for being dispersed with or discharged from the obligations under this tender. Extensions as provided in the contract may be allowed through formal amendments to the contract duly signed by parties to the contract.

18. TERMINATION FOR DEFAULT

The Purchase Committee or the DGP HP may, without prejudice to any remedy for breach of contract, by written notice of default sent to the bidder, terminate the agreement in whole or in part if:

- 1. The Bidder fails to perform any or all of the obligations within the time period(s) specified in the tender document or any extension thereof granted by the Competent Authority.
- 2. The quality of the supplied equipment is not up to the satisfaction of the Competent Authority.
 - 3. The Bidder fails to perform any other obligation under the agreement.

- 4. The Purchase Committee or the DGP HP may at any time terminate the contract by giving written notice to the bidder without compensation to the bidder, if the bidder becomes bankrupt or otherwise insolvent, provided that such termination will not prejudice or affect any right of action or remedy, which has occurred thereafter to the Competent Authority.

19. ARBITRATION

Such person shall be entitled to proceed with reference from the stage it was left by his predecessor if both the parties consent to this effect failing which the Arbitrator shall be entitled to proceed de-novo.
- (e) It is a term of contract that the cost of arbitration shall be borne by the parties themselves.
- (f) It is a term of the contract that the party invoking arbitration shall specify all disputes to be referred to arbitrator.
- (g) Arbitration proceedings shall be conducted in Shimla and the language of the arbitration shall be English.

20. SETTLEMENT OF DISPUTE

All disputes shall be settled in courts of competent jurisdiction situated in Shimla.

21. WARRANTY

The bidder shall provide onsite warranty for 36 months.

22. OTHER CONDITIONS

The Director General of Police HP/ Purchase Committee may cancel the tender and all proceedings relating thereto without assigning any reason. The decision of the authorities shall be final as regards the acceptability of tendered items and items supplied by the bidder and they shall not be required to give any reason in writing otherwise at any time for rejection of the tender or items.

23. TRAINING

The successful firm shall impart training to Police Personnel on operation of equipment free of cost as per date, time and venue to be decided by the Deptt. after procurement.

24. PERFORMANCE SECURITY DEPOSIT

The successful bidder will be required to furnish a Security Deposit @ 7% of the total value of the contract in the shape FDR / Bank guarantee issued by any Indian Nationalized Bank. Performance Security shall remain valid for a period of sixty days from the date of completion of contract including warranty to the best of satisfaction of Procuring Department.
