Vehicle Mounted Camera Systems with accessories, the following amendments/additions are hereby made after pre-bid meeting held on 10/11/2020 as suggested and agreed by vendors attended the meeting:-

Ref. Sr. No. 7. Eligibility Criterion;

7(V) is amended as under:-

Bidder's average annual turnover should not be less than Rs. 50.00 lakh and OEM's average annual turnover should not be less than Rs. 100.00 lakh over last three financial years and should have a Positive Net Worth. The bidder must submit copies of balance sheet of the last three financial years in respect of bidder and OEM duly signed by a Chartered Accountant. The bidder must fill and enclose the prescribed form-VII.

7(III) is amended as under:-

The bidder must upload/submit an attested copy of valid BIS certificate/NABL test report for requisite equipment /item alongwith complete details of equipment covered in the document.

The following criterion are hereby added:-

(X) OEM should be in surveillance business in India for the last 3 years, copy of proof should be uploaded/attached.

(XI) OEM should have supplied mobile surveillance system in India, proof of which should be uploaded/attached.

(XII) OEM should have a proper service support network, escalation matrix for the same should be uploaded/attached.
