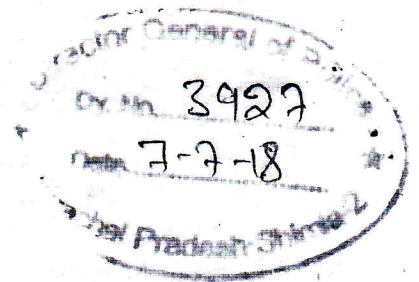


Subject: Providing of employment assistance to the eligible dependents of Martyrs soldiers of para -military forces.
