Subject: - Proposal for the creation of the post of SDPO Banjar District Kullu, Himachal Pradesh alongwith Supporting Staff.

Sir,

Kindly refer to your office letter No. Home -(A) A(1)-2/2018 dated 19.07.2018, on the subject cited above.

2. The Superintendent of Police, Kullu District Kullu, H.P. has intimated that District Kullu being on international tourist map, thousands of Indian/ foreign tourists visit its Banjar valley throughout the year and besides following offices are also functioning at Sub Division Banjar:-

1. SDM office.
2. Tehsil office.
3. PWD Division.
4. IPH.
5. HPSEB.
6. DFO.
7. CHC.
8. BDO office.
9. Degree College
10. Senior Secondary School.
11. The Great Himalya National Park, Sai Ropa (Sainj).
12. NHPC Hudró Power Project.
13. HPCL Hydrol Power project.
14. Other small Hydro power projects.

In addition, a large scale production / trade of crops like apple, peas and vegetables etc. and flow of tourists has led to the increase in vehicular movement in the area which has to be regulated smoothly on regular basis.

Presently there are two Police Sub Divisions viz Manali and Anni in Kullu District. The jurisdiction of Police Station Banjar is under the supervision of Dy.S.P. (Hqrs) Kullu, which is 70 Kms from District Headquarter at Kullu and therefore the creation of post of SDPO Banjar is justified and required to be created in public interest so as to effectively supervise the far flung areas of Banjar Sub Division viz Sojha, Gushaini, Bathar, Ghaliad, Mashiar, Srikot, Neuli, Shanghar, Dingcha, Patan, Bachhut, Teel, Bhion, Percha & Mohini since it is extremely difficult for Dy. SP (Hqrs) to do so from such a long distance.

The local people of the Banjar valley are also found to be involved in drug production and its trafficking. Although a drive against drug traffickers and destruction campaign of cannabis in the valley is launched in the area from time to time, yet the lack of any permanent Gazetted Officer in the Sub Division leads to problems in effective supervisory control. Besides, as and when the SDPO Anni is absent, the supervisory work of SDPO Anni also suffers and if post of SDPO is created at Banjar, he could also be deputed to look after the work of Sub Division Anni during his leave period, it being nearer to Banjar.

For effectively dealing with law and order problems and to closely supervise the work of Police Station Banjar and its subordinate Police Post Sainj, which is proposed to be up graded as Police Station vide this office letter No. P.II (1) Kullu/2018-28863 dated 31.07.2018, it is necessary to create the post of Sub Divisional Police Officer at Banjar.

The areas and population of Banjar Police Station and proposed Police Sub Division is as under:-

1. Area 8,899 Hectare
2. Population 61,417 (31,447 males and 29,970 females).

Pradesh:-

There are following norms for opening/creation of SDPO office in Himachal Pradesh:-

- (i) As per section 11(2) of Himachal Pradesh, Police Act, 2007 provides that 02 or more Police Stations may be assigned to a Police Sub-Division for the purpose of control and Supervision. Sub-Divisional Police office should therefore be established over minimum 02 Police Stations for close and qualitative supervision of Police Station.
- (ii) Himachal Pradesh being a hilly State has varied topography. The purpose of such offices is to provide easy access to the people for getting grievances resolve. The condition of minimum two Police Stations can be waived if Sub-Divisional Police Office has to be open tribal areas, backward areas or areas far away from district Headquarters.
- (iii) Where ever Revenue Sub- Division is created proposal for Police Sub-Division should normally follow if otherwise not feasible. SDM & SDPO should work together with shoulder to shoulder in not only providing service to the people but also maintain general Law & Order of the area.

The following supporting staff is also required for the smooth functioning of SDPO office:-

1. One post of Head Constable as Reader to SDPO.
2. Two posts of Constables (including one post of Constable Driver).
3. One post of Steno-typist.
4. One post of Sweeper Class-IV.

The creation of above post i.e Dy.S.P (SDPO), one Head Constable, two constables (including driver), one Steno-typist and one class-IV (Sweeper) will incur additional expenditure to the tune of Rs. 2705639/- only per annum as per cost statement enclosed as Annexure "A". In addition to this, one light vehicle and installation of land line telephone with broad band facility and computer is also required for smooth functioning of proposed SDPO office.

The recommendation of all Gram Panchyat Pradhans of Banjar Sub Division for the creation of SDPO Banjar with supporting staff is enclosed as Annexure-"B" and may

of the district, including working area/jurisdiction clearly showing/indicating the boundary of Police Station Banjar, is enclosed as "Annexure-C".

The District Magistrate, Kullu District Kullu has also recommended for creation of one post of SDPO Banjar alongwith supporting staff in the public administrative interest, which is enclosed at Annexure-D.

Hence, it is requested that the one post of SDPO Banjar alongwith the proposed staff and logistical infrastructural support may kindly be created at the earliest.
