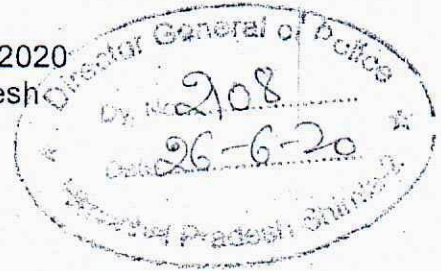

Subject:- Implementation of transfer orders.

I am directed to invite your attention towards the subject indicated above and to say that it has been observed that in cases of transfers where approval of Hon'ble Chief Minister is being conveyed, many proposals are being re-referred for obtaining the approval of Hon'ble Chief Minister for want of condonation of short stay of less than 2 years. It has been decided that in such cases where approval of Hon'ble Chief Minister has been conveyed for condonation of short stay, only such cases may be re-referred where the short stay of less than one year is required to be condoned. In other cases of short stay of 1 year or more, the orders may be implemented and such cases may not be referred back to Chief Minister office.
