The Provisional Seniority List of Senior Assistant in the Police Department indicating the position as it stood on 31.12.2024 was circulated vide this office Memorandum No. P-3-(029)(SLSA)/1/2022-aig hq-GoHP-I/543861/2025 dated 04.01.2025.

2. Vide aforesaid memorandum under reference, objections, if any, against the Provisional Seniority List of Clerk were invited within a month. This office has received following objection against this seniority list :-

Ritesh Bhardwaj Senior Assistant, State CID	The said official has intimated that he was appointed on 25.02.2008 as Clerk on Contract basis and accordingly his services had regularized on 31.07.2014. Further, he has intimated that it is clear that the seniority of contract employees is fixed from their date of their regularization, whereas, the services of those officials who have been regularized after the official i.e 31.07.2014, their names has been shown above the official in the seniority list as issued. Besides above, the official has further intimated that the Govt. of H.P. has issued a letter No. EDUC-E05/30/2024 dated 20.11.2024 to the Education Department vide which the petitioner and non petitioners of the Education Department has	Sh. Ritesh Bhardwaj, Senior Assistant of State CID was appointed on compassionate grounds w.e.f. 25.02.2008 as Clerk on Contract basis and accordingly his services had approved for regularization vide PHQ order dated 26.07.2014) as per inter-se seniority as fixed during his appointment on compassionate grounds alongwith other eligible officials (i.e. the officials mentioned in the seniority list at Sr. Nos. 54 to 61). After completion of all codal formalities as prescribed in the above order, regularization orders of all the above approved officials, have been issued by PHQ on different dates without disturbing their inter-se-seniority as already been fixed at the time of their appointment on compassionate grounds.

		given seniority from their date of appointment on contract basis as per judgment in CWP No. 2004/2017 titled as Taz Mohd Vs State of H.P. & Ors. In view of above, he has submitted a representation with regard to seniority from the date of appointment on contract basis.	Due to this, the officials mentioned above at Sr. No. 54 to 61 have been joined their duties on regular basis in different dates. There is no effect of inter-se-seniority in respect of Sh. Ritesh Bhardwaj irrespective of the date of joining of their batch mates in different dates on regular basis because their regularization was also approved with him by PHQ vide order dated 26.07.2014. As such, the seniority of Sh. Ritesh Bhardwaj Senior Assistant alongwith his batch mates as mentioned above, has rightly been fixed without disturbing their inter-se-seniority as fixed during his appointment on compassionate grounds. It is further intimated that the column-5 of Seniority list i.e date of appointment as Clerk which has been shown in the seniority list, is also the date of joining on regularization not the date of order of regularization. Beside above, the representation in respect of above official with regard to matter of seniority from the date of appointment on contract basis has already been intimated to the applicant vide this office letter dated 28.02.2024 through his controlling officer. However, it is pertinent to mentioned here that the Education Department has reverted its decision regarding grant of seniority from the date of entry in contract service vide notification dated 27.02.2025 (Copy enclosed).
2.	Sh. Surjeet Singh, Senior Assistant, State CID	The said official has intimated that he is disabled in 1st Class category and thereafter he was appointed as Clerk from the post of Constable on medical grounds. Due to this, his disability in 1st Class Category may be entered in the seniority list.	Necessary entries of disabilities have been made in the Seniority List.

3. The necessary objection have been removed in the seniority list as explained above. After the settlement of objection against the provisional seniority List, the final seniority list of Senior Assistant indicating the position as on 31.12.2024 is hereby circulated as per List attached at Annexure-A. No representation, except for clerical omission/mistake will be entertained henceforth.
