NOTIFICATION

Whereas, the draft Himachal Pradesh Police Department (Recruitment of Constables) (Amendment) Rules, 2024 were published in the Rajpatra (e-Gazette), Himachal Pradesh dated 06.03.2024 for inviting objection(s) and suggestion(s) from general public vide this Department's notification of even number dated 04.03.2024 as required under sub-section(1) of Section 141 read with Section 23 of the Himachal Pradesh Police Act, 2007(Act No. 17 of 2007);

And whereas, objection(s) and suggestion(s) so received in this behalf have been duly considered and rejected;

Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 141 read with Section 23 of the Himachal Pradesh Police Act, 2007(Act No. 17 of 2007), the Governor of Himachal Pradesh is pleased to make the following rules further to amend the Himachal Pradesh Police Department (Recruitment of Constables) Rules, 2024 notified vide this Department's notification No. HOME-A-B02/3/2023-HOME-A-HIMACHAL PRADESH SECRETARIAT, dated 29.01.2024 and published in Rajpatra, Himachal Pradesh dated 30.01.2024, namely:-

| Amendment of rule-7 | 2. | | In rule 7 of the Himachal Pradesh Police Department (Recruitment of Constables) |

Rules, 2024 (hereinafter referred to as the said rule), after sub-rule (2), the following new clause shall be inserted, namely:-

"2(a) The requisition for vacancies of Sports Quota shall be sent by the Director General of Police, Himachal Pradesh to the Director, Youth Services & Sports Department to sponsor names. The requisition shall specify the number of posts for each District and the names will be sponsored accordingly."

Amendment of rule-8

3.

In rule 8 of said rule, after sub-rule (1) the following shall be inserted, namely:-

"Note: Age limit for direct recruitment will be reckoned on the first day of the year in which the post(s) is/are advertised for inviting applications or notified to the Employment Exchanges or as the case may be."

Amendment of rule-10

4.

In rule 10 of the said rule, the sub-rule(5) shall be substituted, namely:-

"(5) The dope test may be carried out by the Police department to detect narcotics opiates at the outset of Physical Efficiency Test during the recruitment of Constables."

Amendment of rule-11

5.

In rule 11 of said rule, after the existing provision, the following shall be inserted, namely:-

"The process of recruitment/selection will be as under:-

- 1) The Physical Standard Test & Physical Efficiency Test shall be carried out by the Police Department.
- 2) The scrutiny of all documents related to eligibility for the post

of Constables and award of marks for NCC certificates shall be made by the Police Department."

Amendment of rule-14

6.

In rule 14 of said rule, for the sub-rule (1), the following shall be substituted, namely:-

"The process of medical examination of selected candidates shall be completed by the Police Department."

Amendment of rule-15

7.

In rule 15 of said rule, for sub-rule (1), the following shall be substituted, namely:-

"The verification of character and antecedents of the selected candidate who have been selected provisionally will be carried out by the Police Department through concerned district police but the process for issuance of appointment letters will not be withheld due to pendency of such verification. The appointing authorities will issue provisional appointment letters after obtaining the filled and duly signed attestation form and self declaration from the candidate. In case, a candidate is found to have been convicted in a court of law, the applicant/ candidate shall not be offered appointment irrespective of the nature of the offense and the period of sentence."

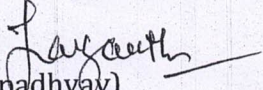
