“ OFFICE CIRCULAR”

The Department is conducting the B-I Test in the current year as per provisions laid down in the Standing Order No.01/2024 issued vide letter No. P-II (9) B-I Test STANDING ORDER /2024-123-156 dated 01.01.2025 and further amended vide letter no. P-II(9) B-I Test Standing Order /2024 – 6783-6818 dated 12.03.2025.

2. The objective of the said test is meant to select the constable to undergo the promotional course (i.e Lower School Course), as per provision laid in PPR 13.7 amended by HP Govt. on 13.06.2008.

3. In accordance with the provisions laid down in the Clause/Para-2 (c) & (d) of the aforesaid Standing Order as well as amended PPR Rule 13.8 (2) (a) notified by the Government of Himachal Pradesh, Department of Home, vide Notification No. HOME-A-B (2)-4/90 Pt. file dated, Shimla-171002, 16.08.2012 circulated to all Heads of Police Offices in HP vide this office letter No.P-II (4) Amendment/2011- 695-725, dated 08.01.2013, only 60% posts shall be filled up on merit through B-I Test subject to passing of Lower School Course likely to fall vacant in a calendar year. In view of above mentioned provision the following number of posts of HCs (executive force) are vacant/likely to fall vacant in this calendar year i.e. in 2025, against which said B-I Test is being conducted :-

SN	Remarks	Number of vacancies
1.	The clear cut number of vacancies in the rank of HCs (i.s 60% posts), against which B-I Test is being held in this year.	877

4. All Heads of Police Offices shall obtain written willingness from all eligible officials in accordance with provisions laid down in the PPR 13.7(2) amended on 13.06.2008, as well as Standing order No. 01/2024 issued on 01.01.2025 and amended on 12.03.2025, and forward the same to the AP&T Office by 5th July 2025 for further action.

5. The eligibility cut-off date for appearing in the B-I Test shall be 31.07.2025 since B-I exam is scheduled on 06.08.2025.



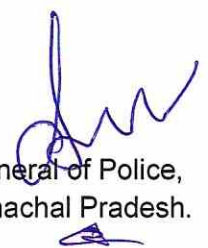
