Re-fixing the tyres mileage criteria of vehicles

Sir,

I am directed to refer to the subject cited above and to say that the following mileage criteria was fixed the Finance Department for replacement of tyre and tube of all vehicle of Government vehicle(s) vide letter No. Fin-I-C(14)1/83-Part-I dated 09.10.1990:-

All Vehicle(s)	In normal areas	In Tribal Areas
1. Replacement of vehicle tyre	18000 KMs	15000 KMs
2. After retreading the tyre	25000KMs	20000 KMs

As over the past three decades, the conditions of roads have improved significantly and road surfaces have also been upgraded and are now mostly paved with blacktop. Besides, the width of the roads have also expanded providing better visibility for drivers and contributing to an improved tyre lifespan. Therefore, the issue regarding re-fixing of the mileage criteria for

replacement of tyres of Government Vehicle(s) has been engaging the attention of the Government for quite some time and after careful consideration, the mileage criteria for this purpose is hereby re-fixed in the following manner:-

As per unladen Vehicle Weight (Internal Combustion Engine)	Mileage for Tyres
Upto 1500 Kg	24000/Kms
B/w 1500 to 1800 Kg	26000 Kms
B/w 1800 to 2500 Kg	28000 Kms
Above 2500	32000 Kms
As per unladen Vehicle Weight (Electrical Vehicles)	Mileage for Tyres
Upto 1800 Kg	20500 Kms
B/w 1800 to 2500 Kg	24000 Kms
Above 2500 Kg	27500 Kms

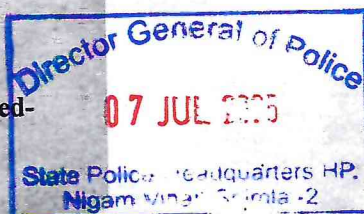
