Subject: Regarding recruitment of HP Police Constable (Male & Female) 2024.

Sir/Madam,

Your kind attention is invited towards the schedule of document verification conveyed earlier vide this office letter No. 19607-22 dated 12.08.2025.

2. In this context, it is intimated that due to heavy rains, landslides, cloud burst and other weather-related issues affecting many parts of the State, and keeping in view the safety and convenience of the candidates, Hon'ble Chief Minister has directed that the schedule of Document Verification of shortlisted candidates for recruitment of Constables-2024 be rescheduled.

3. As per the directions of Hon'ble Chief Minister, the aforesaid document verification process has accordingly been rescheduled, and the revised district-wise schedule is enclosed herewith as Annexure-A.

4. Hon'ble Chief Minister has directed aforesaid rescheduling to ensure that no eligible candidate is deprived of a fair opportunity due to disruption of roads, transportation or communication facilities arising out of the prevailing weather conditions.

You are, therefore, requested to issue a press note at the earliest regarding the aforesaid re-scheduling and ensure wide publicity through newspapers, official websites, Police social media handles and notice boards, so that the information reaches each and every shortlisted candidate in a timely manner.

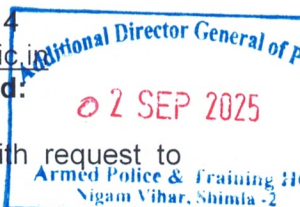

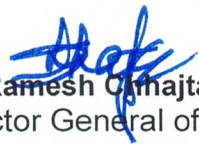
