"O R D E R"

This appeal has been preferred by Shri Inder Singh S/o Sh. Surjan Singh, R/o Village Jimjima, P.O. Dul, Teh. Jogindernagar, District Mandi, H.P., against the Public Information Officer-cum- Superintendent of Police, Welfare, PHQ, HP, Shimla under RTI Act with the reference to the PIO PHQ, H.P. letter No.21291 dated 03.10.2025. This is 1st appeal, filed by the appellant, received on 30.10.2025 to the undersigned.

2. The appellant feeling aggrieved with the decision of the Public Information Officer State Police Headquarter H.P Shimla-2 and filed an appeal on the grounds that "I had deposit one application stepping up of pay through proper channel through Diary No.75/2A dated 10.03.2025 ANTF Kullu, then I have filed the RTI but in the reply of the RTI they had not given any satisfactory answer/reply. That I had put my appeal against this information and it is requested that you have to take the proper action against the application."

3. The brief facts of the case are that the appellant had filed an RTI application which was received to the PIO PHQ on 24.09.2025 under Right to Information Act, 2005 (herein after called the 'Act') wherein he had sought certain information from the PIO PHQ.

4. Accordingly, the PIO State Police Headquarters H.P. Shimla has sought the information from the concerned branches of State PHQ on 27.09.2025. After receiving the report/information from concerned branches i.e. Finance branch and Diary and Dispatch branch of PHQ, the PIO PHQ, H.P. Shimla has informed to the appellant vide letter No.P-III-

5(09)RTI-Inder Singh/2025-(52)-21291 dated 03.10.2025 as per report/information provided by the concerned branches of State Police Headquarters H.P Shimla.

5. I have gone through the appeal of the appellant and the records on file. I have also perused the records/requisite information sought by the appellant. A citizen has a right to seek such information from public authority which is held by the public authority or which is held under its control as per the provisions of the Act. The undersigned also heard the appellant through WhatsApp in the matter, as scheduled on 17.11.2025 at 12:15 P.M. In my opinion, the PIO, PHQ has already informed the appellant in accordance with the report/information provided by the concerned branches.

6. Keeping in view of above, the aforesaid appeal is disposed off accordingly.

7. In case the appellant is not satisfied with this order, he may file an appeal within ninety days from the date on which the decision should have been or was actually received, before the 2nd Appellant Authority-cum-State Information Commission, Himachal Pradesh, Keonthal Commercial Complex, Khalini, Shimla-171002 as per the provisions of RTI Act.
